Item No. 3 & 4 August 29, 2014	<p>Heard. Perused.</p> <p>The ground water pollution by the Respondent Industries is the matter of concern in the present petition. On 22nd April, 2014, It was noted that the status report filed by the Board points out to involvement of 87 industrial units other than the present Respondents, which are the members of the Punjab Small Industries & Export Corporation Ltd. (PSIEC), in discharge of effluent into Dhabi Nala. <i>Prima facie</i>, it indicated that these units might have also contributed to the contamination of the underground water and, therefore, they were directed to be impleaded through the Punjab Small Industries & Export Corporation Ltd. (PSIEC), as party/Respondents. The amended memo of parties was required to be filed by the Applicant in order to have the presence of the</p>

said corporation before us for further effectual and complete adjudication of the controversy in the present matter.
