and rejoinder, if any, be filed by the respective parties by two weeks. No affidavit has been filed by respondent Nos. 1 & 2 regarding number of auto emission test centres as would be required to cater the need of the twin cities viz. Kolkata and Howrah and part of District South 24 Parganas in terms of the issues as raised in our order dated 7th August, 2015. Mr. Pranab Chatterjee, Id. counsel further submits that State respondent has not filed any affidavit relating to number of auto emission test centres under PVD Alipur falling within the part of Kolkata city. The State respondent is directed to file affidavit to that effect by four weeks.

Mr. Kargupta, Id. counsel appearing for the State respondents prays for further time to file affidavit. Leave is granted to file such affidavit as a last chance.

Reports filed by the Commissioner of Police as well as State Pollution Control Board to be considered on the next date of hearing.

For effective adjudication of the issue as framed by us viz. "no PUC no fuel" the Ministry of Petroleum is required to be added as party respondent. Accordingly Ministry of Petroleum be added as party respondent in this proceeding. Registry is directed to take steps in the matter. Respondent

No. 4 and the added respondent are directed to file their respective stand on the point about the feasibility of passing necessary direction to restrict the sale of diesel and petrol from outlets without production of the Pollution Under Control certificate(PUC) issued by the competent authority to control the air pollution as being caused out of automobile emission. As this issue is not confined to any particular State and air pollution due to automobiles is a problem all over India, positive stand of those two Ministries viz. Ministry of Petroleum and Ministry of Environment and Forest and CC is required so that appropriate direction could be passed considering this point. Registry is directed to communicate this order to Ministry of Petroleum, added respondent and to Mr. Gora Chand Roy Choudhury, Id. counsel who will communicate this order to Respondent No. 4. Let affidavits be filed by those respondents by four weeks
