	Having regard to the submission made, we find that the
	applicant is a necessary party in the main proceeding and accordingly,
	the prayer for addition of party is allowed. Registry to amend the
	cause title and allot a respondent Number in respect of this applicant
	in the OA.
	Ld. Adv. for the applicant submits that the owner of the brick
	field is willing to pay the penalty as may be fixed by this Tribunal for
	illegally operating the brick field without any consent to operate from
	the PCB and he intends to file a separate MA to that effect. He is

granted leave to do so.

In the meantime, the Superintendent of Police, East Midnapore is directed to make physical verification of the brick field in question and submit a report on the issue whether the unit is closed or is operating without consent from PCB, despite closure order, and if it is operating without consent, the number of bricks manufactured and number of unsold bricks lying in the respective brick field areas and if it is closed the date from when it is closed. Such report be filed within two weeks.

Registry to communicate this order to the Superintendent of Police of West Midnapur immediately. Mr. Kargupta, ld. adv. is also directed to communicate this order to the SP, West Midnapur.

MA 245/2016/EZ stands disposed of.
