flowing within the limits of Nagar Nigam, Haridwar. We, therefore, appoint Learned Advocate, Mr. Shariq Zaidi, Advocate to visit Haridwar, Uttarakhand, to carry out local investigation the bank of river Ganga flowing within the limits of Nagar Nigam, Haridwar and report to us about the condition presently obtaining there, particularly with regard to dumping of Municipal Solid Waste. Municipal Engineer, Nagar Nigam, Haridwar shall accompany the Local Commissioner appointed to carry out local investigation and wherever dumping/littering of MSW is observed along the bank / flood plains of River Ganga, the Local Commissioner may give instructions to Municipal Engineer for removal of the same forthwith from the site. He shall report to us on the next date of hearing. Fees of Rs. 20,000/- shall be paid by the Nagar Nigam, Haridwar to the Local Commissioner and shall arrange for the transport and such other facilities to the Local Commissioner to carry out the local investigation effectively. Local Investigation shall be carried out within 10 days from today. Municipal Engineer, Nagar Nigam Haridwar shall report to us the location of dumping of MSW so removed from the banks/flood plain of River Ganga.
