Item No. 5 March 27, 2014	<p>Service on all the Respondents complete. Respondent 1 & 4 appeared. No one is represents for the respondent No. 2 & 3. They are also absent. The Learned Counsel appearing for the Respondent No. 4 files a preliminary submission which reveals that no action was taken pursuant to the order of the Tribunal dated 25/04/2013. Learned Counsel appearing for Respondent No. 1 seeks time to file reply.</p> <p>The order directs Respondents 1, 2 & 3 to take immediate action to shift the dumping ground "Hada Rori" to a suitable place outside the limits of Municipal Council and if necessary by acquiring suitable land. It is submitted that no land was so far acquired and the dumping ground was not shifted. It is clear that no action was taken pursuant to the directions. Hence, we find it necessary to direct the Chief Executive Officer of the Respondent No. 1 to appear personally on the next day of hearing.</p> <p>Respondent No. 2 & 3 though received notice did not appear. As Respondents 2 & 3 did not appear consequently, we issueailable warrant against Respondent No. 2 & 3 in the sum</p>

of Rs. 10, 000/- for their appearance to the satisfaction of the arresting Officer in exercise of our powers and in terms of the provision of Section 19 (4) (a) of the National Green Tribunal Act, 2010 read with Order XVI Rule 10 (3) and Section 151 of Code of Civil Procedure, 1908 to be executed by the SSP Hoshiarpur and SSP Chandigarh, respectively.
