UPON hearing the counsel the Court made the following  
O R D E R

All the added respondents have been served.

In terms of the order dated 10<sup>th</sup> January, 2025, we direct all the respondents/States to file their affidavits in response to the affidavit dated 5<sup>th</sup> September, 2024 filed by the petitioners and in particular six points specified in the letter dated 23<sup>rd</sup> August, 2024 annexed to the said affidavit. The learned senior counsel appearing for the petitioners states that in particular, all the States will have to deal with clause 'c' of the letter dated 23<sup>rd</sup> August, 2024 very specifically.

Finally we grant time of one month to all the respondents/States to file their affidavits in terms of the above directions.

We permit the learned senior counsel appearing for the petitioners to file on record a chart setting out the compliances made by various States and the Union of India.
