- 1. I respectfully submit that I am conversant with the facts of the case and competent to swear this affidavit.
- 2. I respectfully submit that in compliance with the Hon'ble NGT order dated 11.09.2024, the Puducherry Pollution Control Committee (PPCC) has taken steps to fill up the three vacant posts in the PPCC.

- 3. I respectfully submit that the State Government of Puducherry vide G.O Ms.No.12/2016-Envt., and G.O Ms.No.14/2016-Envt dated 25<sup>th</sup> August 2016 established and notified the State Air Laboratory under section 28 (1)(a) of the Air (Prevention and Control of Pollution) Act, 1981 and State Water Laboratory under Section 52 (1) (a) of the Water (Prevention and Control of Pollution) Act, 1974 for the Puducherry Pollution Control Committee (PPCC). (Annexure I).
- 4. I respectfully submit that the Puducherry Pollution Control Committee (PPCC) Laboratory has obtained the National Accreditation Board for Testing and Calibration Laboratories (NABL) Certification as per ISO / IEC 17025: 2017, General Requirements for the Competence of Testing & Calibration Laboratories. The certificate is valid till 28/11/2025. (Annexure II).
- 5. I respectfully submit that in the U.T of Puducherry, there is no Environmental Laboratories established and notified under Section (12)(1)(a) of the Environment (Protection) Act, 1986. Expanding the existing Laboratory of Puducherry Pollution Control Committee (PPCC) is also not currently feasible due to space constraints, as it operates from a rented facility.
- 6. I respectfully submit that the Government of Puducherry has approved for the construction of an integrated Office building and Laboratory for Department of Science, Technology & Environment and Puducherry Pollution Control Committee and tenders were floated by the Public Works Department. The work order will be issued shortly. Upon completion, the building will house a State-of-the-art laboratory equipped with sophisticated instrumentation and other necessary infrastructure. Necessary action will be taken to establish

an Environmental Laboratory in accordance with Section (12)(1)(a) of the Environment (Protection) Act, 1986.

- 7. I respectfully submit that PPCC proposes to strengthen the Air and Water Laboratory for monitoring various notified parameters after the construction of the integrated office building cum Laboratory.
- 8. I respectfully submit that the PPCC has two laboratories, one functioning at Puducherry and the other at Karaikal Region of U.T of Puducherry. The existing Laboratory at Puducherry has NABL accreditation.
  - 9. I respectfully submit that the Puducherry Pollution Control Committee (PPCC) will fill up all the three existing vacancies within a period of four months. In this connection, necessary advertisement has been hosted in the website of the Department and published notice in the Newsdaily / Rojgar on 28.12.2024 inviting applications for filling up the post of Environmental Engineer through Deputation / promotion in PPCC as per the existing Recruitment Rules. Necessary measures were also taken to fill up the one vacant post of Scientist B by promotion as per the recruitment rules (Annexure III).
  - 10. I respectfully submit that to address the man power shortage, PPCC has taken steps for recruiting (6) Nos of Technical Consultants and (3) Nos of Scientific Consultants through outsourcing. Since PPCC doesn't not have any administrative officials to handle the administrative matters, PPCC has proposed to hire 4 Nos. of retired Government officials as Consultants for handling Administrative and Accounts matters. PPCC is also reviewing the


