 - "5. Though from that order it appears that the direction of Hon'ble the Supreme Court is to all the States to fill up the vacancies of PCBs/PCCs by 30.04.2025 but since Counsel for GNCTD has submitted that the said direction applies to the States falling within NCR, therefore, we hereby direct that the State/UT

not covered by the order of the Hon'ble Supreme Court dated 27.08.2024 will also fill up the posts lying vacant in the SPCBs/PCCs latest by 30.04.2025. All the possible efforts will also be made within this period to provide adequate infrastructure in the laboratories of the PCBs/PCCs and to make them fully functional.

6. We also take note of the fact that in some of the States/UTs the adequate number of laboratories do not exist, therefore,

expeditious steps will be taken to cure it.

7. Let the progress report indicating the compliance of this order be filed by all the States/UTs by way of an affidavit by providing an advance copy to the Counsel for the CPCB at least one week before the next date of hearing."

That before proceeding further, it is appropriate to mention here 3. that a status report was filed on 01.04.2024 on behalf of the State of Uttar Pradesh before this Hon'ble Tribunal, wherein the details of the total sanctioned posts including vacancy in Uttar Pradesh Pollution Control Board (UPPCB).

That further vide its order dated 11.09.2024 this Hon'ble Tribunal has direct the State/UT not covered by the order of the Hon'ble Supreme Court dated 27.08.2024 to fill up the posts lying vacant in the SPCBs/PCCs latest by 30.04.2025. Furthermore, this Hon'ble Tribunal has also directs the PCBs/PCCS to made all possible efforts within this period to provide adequate infrastructure in the laboratories of the PCBs/PCCs and to make them fully functional. That an information regarding to the number of sanctioned and vacant post along with the reason for not filling up the vacant posts and the details of correspondence with Uttar Pradesh Subordinate Service Selection Commission (UPSSSC) to fill up the said vacant posts on a tabulated format is annexed herewith as Annexure No.-

That it is pertinent to mention here that vide its letter dated 6. 24.08.2024 and 30.10.2024 the UPSSSC has recommendation regarding 42 posts of Junior Engineer against 43

vacant posts. In pursuance to the above recommendation the UPPCB has issued an office order dated 10.09.2024 and 12.11.2024 regarding appointment of Junior Engineers against 42 posts.

It is also worthwhile to mention here that against the 42 vacant posts of Junior Engineer till date 27 vacant posts has been filled and they have taken charge on the said posts.

- 7. That in pursuance to the letter no.-PCP/NGT/693 of 2023/2023-24 dated 23.04.2024 Sent by the CPCB an information regarding the infrastructure of the laboratories under Water (Prevention and Control of Pollution) Act, 1974, Air (Prevention and Control of Pollution) Act, 1981 and Environment (Protection) Act, 1986 is being annexed herewith as **Annexure No.-2** on the tabulated format.
- 8. That an information of budget available with the UPPCB and its sources and expenditure for the financial years i.e. 2022-2023 and 2023-2024 (in Lakhs) in tabulated format is annexed herewith as **Annexure No.-3**.
