the Department of Irrigation.

According to the statement made various builders/developers have violated, breached and/or trespassed on the flood plain by raising constructions. Before we pass any direction in that behalf it will be required by the Tribunal to provide an opportunity to all the 19 builders/developers which have been mentioned in the tabulated statement. They are at liberty to file their responses within one week from today.

Let response to these comments, with the documents that they wish to file, be filed within the stipulated period and the matter be listed for arguments and direction in that behalf.

We make it clear that we will not grant any further opportunity to any of the parties.

List this matter for hearing on 08th July, 2016 at the end of the board.

We direct the Learned Counsel appearing for Development Authority to place on record status of these 19 builders in relation to collection and disposal of Municipal Solid Waste; sewage connection and establishment of STPs and manner of disposal of treated sewage water.

The Learned Counsel appearing for various builders/developers submit that they are willing to put up STPs plant to ensure discharge of only treated waste. Such details should be furnished on next date.
