<b>Item No. 01 March 17, 2016</b>	<p>Today we have heard Respondent No. 15, 8, 9 and Respondent No. 11, CPCB.</p> <p>Learned Counsel appearing on behalf of the Respondent No. 8 and 9 submits that these Respondents are occupying the land which is not part of the green belt being Khasra No. 299/2 of village Prahladgarhi, Tehsil and District Ghaziabad and affidavit dated 25<sup>th</sup> September, 2014 to that effect has been tendered by the Respondent No. 8 and 9. According to him, the expert committee erroneously</p>

reported (Page 183) that these Respondents have encroached upon the Green Belt. Learned Counsel appearing on behalf of the Applicant submits that besides Expert's Committee Report i.e. Affidavit of Respondent No. 5, GDA reveals that these Respondents are encroachers upon the Green Belt.

Learned Counsel appearing on behalf of the Respondent No. 16 & 19 submits that they are also unfortunately, placed in similar situation in as much as they are erroneously shown to be occupying land marked as green belt, though they are on Khasra No. 299/1 & 2 of village Prahladgarhi.

Learned Counsel appearing on behalf of the Applicant submits that the GDA has also shown these respondents as the encroachers of the Green Belt.

Now the concerned respondents have quoted the land Khasra Nos. We, therefore, direct the Respondent no. 5, GDA to verify with reference to the Master plan and the revenue records and report as to whether these Khasra Nos. are notified as a Green Belt or not.

We would like Respondent No. 5, GDA to place its report before us on or before 22<sup>nd</sup> March, 2016.

List this case for further hearing tomorrow i.e. 18<sup>th</sup> March, 2016.
