Learned Counsel appearing for Respondent No. 1 seeks time to file the Reply. The case of the Applicant is that the Municipal Solid Wastes are dumped without following the Municipal Solid Wastes Rules. As seen from the photographs produced, the Municipal Solid Wastes are dumped at Shahabad (Mithapur) without following the Municipal Solid Waste Rules. The District Magistrate, Ghaziabad is directed to submit a status Report on the allegations raised in the application in the light of the photographs annexed to the application. The Report shall be submitted within two weeks. Respondent No. 1 shall submit the Reply within two weeks with advance copy to the Applicant who may file Rejoinder, if any, within one week thereafter.</p> <p>Learned Counsel appearing for Respondent No. 2 is absent and there is no representation for the second respondent. Consequently, we issue bailable warrant against the Municipal Corporation Ghaziabad i.e. Respondent No. 2, in the sum of Rs. 10,000/- to the</p>

satisfaction of the arresting Officer, in exercise of our powers and in terms of the provision of Section 19 (4) (a) of the National Green Tribunal Act, 2010 read with Order XVI Rule 10(3) and Section 151 of Code of Civil Procedure, 1908 for his appearance on April 25<sup>th</sup>, 2016.
