	on the forest lands.
	This fact is contradicted by the applicant and he

	We have no feed beck from the Learned Counsel
	appearing on behalf of the District Magistrate.
	Consequently, we issue bailable warrant against the
	District Magistrate, South District to remain present

before the Tribunal in the sum of Rs. 10,000/- to the satisfaction of the arresting Officer, in exercise of our powers and in terms of the provision of Section 19 (4) (a) of the National Green Tribunal Act, 2010 read with Order XVI Rule 10(3) and Section 151 of Code of Civil Procedure, 1908. Bailable warrant is to be executed through the Station House Officer, concerned Police Station with the instructions to furnish the facts and figures as to what he has done for removal of the encroachments lying in the forest area. We also issue notice to District Magistrate of the coercive action which may follow in terms of the Order XXI Rule 32 of CPC, 1908, in the event of inaction being detected.
