Item No. 08 November 16, 2015 ss	<p>All the Noticees, Builders as well as Colony Residents have been served with the Notices. Service is complete. By way of last opportunity we grant two weeks time to all the Noticees, who have not filed their replies. Their replies should be filed within time with advance copy to all the Learned Counsel appearing in this case. Applicant and Public Authority respondents are directed to file Rejoinder to the replies filed by these Authorities.</p> <p style="text-align: center;">In the meanwhile we direct the Learned Counsel</p>

appearing for Respondent No. 7, 10, 12, Uttar Pradesh Pollution Control Board, U.P. Jal Board and the State of Uttar Pradesh to file comparative chart before the Tribunal within two weeks from today and provide the Status of each of the Noticees in this case. It shall be stated if required, they have Environmental Clearance or not, whether they have sewer connection or not, if the building plan have been sanctioned and whether any STP/CEPT was provided or not and if provided whether it has been constructed and operational at the site or not.

The cases of the Noticees who are discharging sewage and other waste directly into the river Yamuna, for which we had passed prohibitory order and according to the Authority concerned the site outlet is closed or sealed, complete detail shall be provided particularly in relation to the contributory, who are discharging their waste through this pipeline.

The case in relation to cleaning of Municipal Solid Waste dumping on the river bank of East Gate Nallah of Taj, be listed on 19th November, 2015.

The Learned Counsel appearing for the respective Authorities assure us that within two days it will be cleaned.

List this matter for final hearing on 09th December, 2015.
