Item No.4 1st February, 2016 Order No.1	<p>Heard. Perused Application.</p> <p>Order dated 29th September, 2015 disposing of Application No.92/2014 required the preparation and publication of the maps showing Silence Zone within the limits of Municipal Corporation of Greater Mumbai (MCGM) within four (04) months time. Respondent No.5 Municipal Corporation of Greater Mumbai which is under obligation to prepare and publish the maps has moved this Application for grant of three (03) more months time for discharging its obligations fully.</p> <p>According to Respondent No.5 MCGM, work of mapping in 8 Wards out of total 24 Wards has been completed and balance work of mapping of 16 Wards would be completed within two or three months. Learned Counsel appearing on behalf of Respondent No.5 submits that MCGM will be publishing the maps showing Silence Zone in 8 Wards on its website for the benefit of the public at large and shall adhere to the discipline of publishing the maps of the remaining Wards on the website from time to time as and when the same are prepared.</p> <p>We believe that the publication of the maps showing the Silence Zon, may be of some Wards, promptly would benefit the public at large and will alleviate their difficulties in some measure, if not complete.</p> <p>We, therefore, grant two (02) months time to Respondent No.5 to expeditiously carry out and finish work of mapping of remaining 16 Wards and facilitate the public at large to understand which are the Silence Zones in the respective Wards.</p>
