October 11, 2013**

By this Order, we will deal with the above 5 cases together as common question with regard to collection and disposal of municipal solid waste arises in these cases.

In Original Application No. 34(T<sub>HC</sub>) of 2013 a proposal has been placed on record before the Tribunal in regard to establishment of a Municipal Solid Waste Plant which we will be considered as leak proposal.

However, in this proposal there are certain issues which *inter alia* require attention of the experts and the State Governments, as to employees welfare, time management for collection and disposal; distribution of bins, responsibility of various parties; collection and segregation; and role attributable to each party; and manner in which multi parties responsibility should be fixed so as to ensure the proper execution of the Project.

Let the Secretary, Local Government, Punjab would examine this aspect and make an addition to the Report submitted in this regard before the next date of hearing positively.

Learned counsel appearing for Original Application No. 40(T<sub>HC</sub>) of 2013 prays for time to file an Affidavit of the Deputy Commissioner. Let the same be filed during the course of the day as prayed.

We direct all the parties appearing in these cases to examine the Model projects submitted by the Authorities in the Pathankot and make their suggestions, if any, in relation to all clusters particularly one those are subject matter of the above notification.
